

William H. Rheinfrank Award

- Purpose** To recognize a person or organization that has provided a positive, far-reaching impact on public works programs, services, or policies through distinguished public service and commitment to their community and the State of Wisconsin.
- Eligibility** Candidates may be any person or organization serving in a public works related field or special endeavor. Candidates may come from the public or private sector and from any level within the organization from labor to executive. APWA membership is not required.
- Selection** The Awards Committee reviews the nominations and selects the award winner.
- Nomination Process** Nominations may be made by any entity or individual APWA members or non-members. Original submittal should include nomination form and documentation supporting the purpose of the award and the award's eligibility requirements. Four copies of the submittal are required. Materials submitted in support of nomination will not be returned. The nomination and supporting data forms are available on the Chapter website, <http://Wisconsin.APWA.net>.
- Deadline** January 31, Annually
- Presentation** The winner is recognized at the Spring Conference of the Wisconsin Chapter of APWA and will be featured in the chapter newsletter.
- History** The award is named in honor of William J. Rheinfrank who was president of the Wisconsin Chapter in 1962. He began his long career with the Milwaukee Department of Public Works as a clerk in the Water Department in 1926. When he retired on Jan. 18, 1970, he had served 43 years in the Department of Public Works, with the last 18 years as Superintendent of Street Sanitation. It was in snow fighting that Mr. Rheinfrank made his greatest and most visible contribution. He was instrumental in converting the City's ill-equipped system into "the best department in the Midwest snow belt region." He continually campaigned for better equipment and training and by 1965 had published a comprehensive snow-fighting plan called "Snow Plowing and Ice Control Procedures."

At the National level he was active in the Institute for Solid Waste and the North American Snow Conference. He received the Samuel A. Greeley Award in 1952.

A bequest from the Rheinfrank Estate was given to the Wisconsin Chapter of APWA to be used specifically for the education and scholarship fund. The award is given in memory of Mr. Rheinfrank for his dedication and contribution to public works in the State of Wisconsin.
